Wellness Counselling is an occupation that offers great fulfilment for people



interested in the services professions. Wellness counsellors work in wellness centres, private practices, and at NGO's, clinics, community centres and schools. They offer support to people who face mental, emotional and physical health challenges that involves counselling and coaching.

Counselling means entering into a helping relationship with the client with the aim of rendering support, encouragement and guidance in order to solve problems,

improve relationships and learn life skills to improve coping. **Coaching is** the facilitation of a process by which a coach directs and trains a client in self-care, personal growth, development and the principles of success with the aim of fulfilment in living "the good life".

Wellness is the new approach in health care. We understand health as *a positive state of mental, emotional, social and physical wellbeing* (World Health Organization policies).



There is a vast need in SA for wellbeing consultants that can offer comprehensive

counselling and coaching services over a wide spectrum of holistic support. These professionals make use of a variety of modalities such as talk therapies, body and somatic therapies, as well as herbal and nutritional support.

The wellness programme is facilitated by the Synergetica Tutor centre and requires

practical experience is also made at a wellness centre under supervision. Optional classes are offered at the Synergetica Campus from time to time.

The counselling programme is aligned to the HW SETA registered skills programme which forms part of the Further Education and Training Certificate in Counselling. The training programme is 30% theory and 70% practice. Shadowing and mentoring is available to candidates.

Mode of delivery

Distance training short courses. The candidate is required to complete the prescribed assignments based on the study guides and submit it for assessment. Optional classes are offered on a monthly basis at the Synergetica Campus just outside of Pretoria. Practical work can be arranged to gain experience.

The ten modules have an assignment each that needs to be completed in order to compile a portfolio of evidence. Tutoring classes are offered from time to time (dates included in your study letter upon registration.

Registration at the professional body

Candidates may register at the Natural Healers Association as Candidates/Students for the course of their studies and upon completion of the short courses migrate to the ASCHP or upgrade to Wellness Health Care Counsellor.

Registration as Supportive Counsellor

Upon completion of the skills training programme candidates will qualify for registration as



Supportive counsellors (NQF Reg. No. 645) with the ASCHP – a SAQA registered professional body (SAQA ID 984) for counsellors with designations registered on the National Qualification Framework (Act 67 of 2008). A professional body fulfils the important function to provide counsellors with the following services:

- Professional guidelines
- Legal scope of practice
- Ethical code with disciplinary measures

Without registration with such an association counsellors cannot practice professionally. Members are protected by their registration in a specific category and will benefit further by annually doing Professional Continuous Development training (CPD's).

Registration at ASCHP is determined by your level of qualification and practical experience. The following designations are available:
